MMOLELEDI WA MALAPA KE MANG

Mmoleledi wa malapa ke mohlankedi wa boithutelo molaong yoo a thwetšwego ke Kgoro ya Toka le Tihabollo ya Molaotheo go godiša le go šireletša dikgahlegelo tša bana dithulanong tša segae mabapi le maikarabelo le ditokelo tša batswadi.

Mmoleledi wa malapa a ka, go ya ka molao, thwala Mogakolli wa Malapa yoo e lego mošomedi wa tša leago yo ngwadišitšwego goba mosaekholotši go bathuša ka tsebo ye rilego dinyakišišong.

MMOLELEDI WA MALAPA O DIRA SE KA TSELA EFE?

Mmoleledi wa Malapa o thuša baamegi go fihlelela tumellano dithulanong mabapi le hlokomelo le boikgokaganyo bja bana, ka bonamodi. Ge bonamodi bo sa šome, baamegi ba ka tšwelapele ka tharollo ya morero wa bona kgorotshekong.

Mešomo ya Mmoleledi wa malapa e okeditšwe ka Molao wa Bana (Molao 38 wa 2005) wo mofsa mme bjale e akaretša tše latelago:

- Go thuša baamegi ka go thala ditumellano le mananeo a botswadi a maikarabelo le ditokelo tša batswadi.
- Go ngwadiša mananeo a botswadi le ditumellano tša maikarabelo le ditokelo tša botswadi.
- Go fetiša goba go fediša ditumellano tša maikarabelo le ditokelo tše ngwadišitšwego ke Mmoleledi wa Malapa.
- Go fetiša goba go fediša mananeo a botswadi ao a ngwadišitšwego ke Mmoleledi wa Malapa.
- Mmoleledi wa Malapa gape o thuša ka tharollo ge go na le thulano malebana le gore naa tate yoo a sego a nyala wa ngwana o na le maikarabelo le ditokelo goba aowa.
- Go dira nyakišišo le go dira ditigelo go kgorotsheo ka gore dikgahlegelo tše kaone tša ngwana ke dife.
- Go dira dinyakišišo ka ga melato ya hlokomelo le bošoro bja segae yeo e rometšwego ke kgorotsheo.
- Molao wo gape o akareditše Kwano ya Hague ya Tšhabišo ya Bana ya Boditšhabatšhaba mme wa e dira karolo ya molao wa Afrika Borwa. Kantorolo ya Mmoleledi Mogolo wa Malapa e beilwe bjalo ka Bolaodi bja Bogareng tiragatšong ya Kwano ye.

Gopola: Ditumellano tša maikarabelo le ditokelo tša batšwadi le mananeo a botswadi di šoma fela ge dingwadišitšwe go Mmoleledi wa Malapa goba didirilwe taelo ya kgorotsheo.

MAIKARABELO A BOTSWADI KE ENG

Maikarabelo a botswadi le ditokelo di akaretša, hlokomelo ya ngwana, boikgokaganyo le ngwana, swaro ya ngwana le hlokomelo ya ngwana.

MMOLELEDI WA MALAPA O DIRA SE KA TSELA EFE?

Ka kgopelo ya moamegi ofe goba ofe goba ka taelo ya kgorotsheo, Mmoleledi wa malapa o botšološa baamegi mmogo goba ka karogano ge go hlokega, bakeng sa go netefatša maemo a bona ke dintlha tša morero.

Mmoleledi wa Malapa gape o botšološa ngwana ka thušo ya Mogakolli wa Malapa bakeng sa go hwetša le go tšweletša dipono tša ngwana kgorotshekong mabapi le morero, mme le go šireletša ngwana kgahlanong le go nea bohlatse kgorotshekong yeo e ka tšwago e le yeo e sa molokelago.

Mmoleledi wa Malapa o thuša baamegi go fihlelela tharollo ya tumellano mme le ye šomago ka bonamodi ka go diriša tsebo ya gagwe ya molao le mabokgoni a tharollo ya dithulano morerong. Ge maloko a ka fihlelela tumellano Mmoleledi wa Malapa o tla thuša ka go thala lenaneo la botswadi goba tumellano ya maikarabelo le ditokelo yeo e ka ngwadišwago le Kantorolo ya Mmoleledi wa Malapa goba ya dirwa taelo ya kgorotsheo.

Ge baamegi ba sa fihlelele tumellano, Mmoleledi wa Malapa o tla dira pego ya go kgorotsheo mme a dire tigelo go ya ka nyakišišo yeo e dirilwego.

DIKHOLEGO TŠA KAMEGO YA MMOLELEDI WA MALAPA KE DIFE?

- Ge baamedi a fihlelela tumellano ka ga merero yeo ba nago le thulano go yona, morero o ka se išwe kgorotshekong, mme se se tla boloka ditshenyagalelo mabapi le tšhepetšo ya molao le nako.
- Ditumellano tša maikarabelo le ditokelo tše di ngwadišitšwego le Mmoleledi wa Malapa di na le tlamorago ya molao ye swanago le ya tše di dirilwego taelo ya kgorotsheo. Mananeo a botswadi gape a ka ngwadišwa le Mmoleledi wa Malapa.
- Mmoleledi wa Malapa a ka fetiša goba a fediša ditumellano tša maikarabelo le ditokelo tše ngwadišitšwego ke Kantorolo ya Mmoleledi wa Malapa. Se se bolela gore ga go hlokego ya gore baamegi ba lebe kgorotshekong bakeng sa

phetošo ya tumellano ge go hlokega.

- Mmoleledi wa Malapa o diriša tsebo ya molao le mabokgoni a tharollo ya thulano go thuša batswadi go fihlelela tharollo ya kwano thulanong ya bona yeo e amogelegago go kgorotsheo.
- Dikgorotsheo, go ya ka molao, di swanetše go eleletša pego le/goba ditigelo tša Mmoleledi wa Malapa ge di dira sepheto mabapi le gore dikgahlegelo tše kaone tša ngwana le dife.
- Thulano e ka rarollwa ka bonako ntle le go sepetša ngwana tšhepetšong yeo e sa moswanelago ya go ya kgorotshekong.
- Mmoleledi wa Malapa o diriša mokgwa wa go hloka kgethollo go sa kgathalatšege gore kgopelo e dirilwe ke mang mme o šireletša dikgahlegelo tše kaone tša ngwana.

NAA O BONA NENG MMOLELEDI WA MALAPA?

Baamegi ba ka ikgokaganya le Mmoleledi wa Malapa ge go na le thulano/ go se kwane mabapi le dikgahlegelo tše kaone tša ngwana e.g.-

- ✓ Ge go na le thulano malebana le swaro, boikgokaganyo le hlokomelo ya ngwana
- ✓ Ge ba nyaka go thala ditumellano tša maikarabelo le ditokelo goba mananeo a botswadi
- ✓ Ge ba nyaka go ngwadiša ditumellano tša maikarabelo le ditokelo tša botswadi goba mananeo a botswadi
- ✓ Ge ba nyaka go fetiša goba go fediša ditumellano tša maikarabelo le ditokelo tša botswadi goba mananeo a botswadi ao a ngwadišitšwego le Mmoleledi wa Malapa
- ✓ Ge go na le thulano ya gore naa tate yoo a sa nyalago wa ngwana yo belegwego ka ntle ga lenyalo o fihleletše dinyakwa tša go mo kgontšha go fihlelela maikarabelo le ditokelo tša botswadi ka botlalo go ya ka Molao
- ✓ Bakeng sa tšhabišo ya bana ya boditšhabatšhaba
- ✓ Dikgorotsheo gape didira ditaelo tša gore Mmoleledi wa Malapa o swanetše go dira dinyakišišo ka gore ke eng seo se lego dikgahlegelong tše kaone tša ngwana.

KE MANG YO LEFELAGO MMOLELEDI WA MALAPA?

Mmoleledi wa Malapa o thwetšwe ke Kgoro ya Toka le Tihabollo ya Molaotheo mme o phethagaleletša ditirelo setšhabeng ntle le tefelo, ka tshenyagalelo ya pušo. Baamegi ba thulano ya molao ba ka

swanela ke go lefela ditelokoketšego tša dipego tša ditsebi, mohlala, phetleko ya mosaekholotši, le diteko tše dingwe tša forensiki ge dihlokega bakeng sa go laetša dikgahlegelo tše kaone tša ngwana.

NAA MOTHO O HWETŠA KAE MMOLELEDI WA MALAPA?
