214. (1) UMthetho wePalamente mawuthethe—
- (a) ngokwahlulwa-hlulwa okulinganayo kwengeniso ezuzwe elizweni lonke isahlulelwa urhulumente wezwelonke, noorhulumente bamaphondo, noorhulumente basekuhlaleni;
- (b) ngokuqingqwa kwesabelo esifanelekileyo sephondo ngalinye kuloo ngeniso;
- (c) nangokwabelwa kumaphondo, koorhulumente basekuhlaleni okanye koomasipala kwesabelo sikarhulumente wezwelonke kuloo ngeniso, kwakunye nemiqathango oko kwabiwa okunokwenziwa phantsi kwayo.
- (2) UMthetho ekuthethwe ngawo kwisiqendwana (1) unokuwiswa kuphela emva kokuba kubonswene noorhulumente bamaphondo, norhulumente wasekuhlaleni ocwangcisiweyo kunye neKomishoni yeeMali neeRhafu, zaza zaqwalaselwa izinto ezinconyelwa yiKomishoni, kwaye makucingelwe—
- (a) okuya kuba luncedo elizweni lonke ;

- (b) naliphi na ilungiselelo emalenziwe mayela netyala nelizwe nezinye iimbopheleleko zelizwe;
- (c) iimfuno nemicimbi yorhulumente wezwelonke, egqitywa ngokweemfuneko ezinokubonelela;
- (d) imfuneko yokuqinisekisa ukuba amaphondo noomasipala ayakwazi ukunika uluntu iinkonzo ezisisiseko aze enze imisebenzi ayabelweyo;
- (e) ukukwazi ukuhlawula iirhafu nokusebenza ngokutyibilikayo kwamaphondo noomasipala;
- (f) iimfuno zophuhliso nezinye iimfuno zamaphondo, zoorhulumente basekuhlaleni noomasipala;
- (g) ukungalingani ngokoqoqosho ngaphakathi kumaphondo naphakathi kwelinye iphondo nelinye;
- (h) iimbopheleleko anazo amaphondo noomasipala ngokomthetho wepalamente wezwelonke;
- (i) ukunqweneleka kokwabiwa kwezabelo zengeniso okuzinzileyo nokubonakala kusengaphambili; kunye
- (j) nemfuneko yokuba bhetyebhetye ekusabeleni kwiimeko zequbuliso okanye ezinye iimfuno zexeshana nezinye izinto ezisekelwe kwiimfuneko ezifanayo ezinokubonelela.

215. (1) Ulwabiwo-mali lwezwenonke, olwamaphondo noloomasipala neenkqubo zolwabiwo-mali mazikhuthaze ukusebenzela elubala, ukuphendula, nokuphathwa ngempumelelo koqoqosho, kwamatyala norhulumente.
- (2) Umthetho wepalamente wezwelonke mawuxele –
- (a) uhlobo omalube lulo ulwabiwo-mali lwezwenonke, olwamaphondo noloomasipala;
 - (b) ukuba maluthiwe thaca nini na ulwabiwo-mali lwezwenonke nolwamaphondo; nokuthi
 - (c) ulwabiwo-mali kwinqwanqwa ngalinye likarhulumente malubonise imithombo yengeniso nendlela eya kuthi ngayo inkcitho ecetywayo ivisisane nokufunwa ngumthetho wepalamente wezwelonke.

- (3) Ulwabiwo-mali kwinqwanqwa ngalinye likarhulumente malube –
- (a) noqikelelo lwengeniso nenkcitho, lwenze umahluko phakathi kwemali ekhoyo nenkcitho ekhoyo;
 - (b) namacebo okuhlawulela nakuphi na ukunqongophala kwethuba lexesha okwenzeka kulo; kananjalo
 - (c) lubonise ukuba ziyintoni iinjongo ngokuboleka nezinye iintlobo zokungen' ematyaleni kukarhulumente okuya kuthi kwandise ityala likarhulumente kunyaka oza kuthi ulandele.

216. (1) Umthetho wepalamente wezwelonke mawuseke inxili yesizwe kwaye uxele iindlela zokuqinisekisa ukusetyenziswa kwawo elubala nokulawulwa kwenkcitho kwinqwanqwa ngalinye likarhulumente, ngokuthi gqi–
- (a) nendlela yokubal' imali evunyiweyo ngokubanzi;
 - (b) nokudweliswa kwenkcitho okufanayo; kwakunye
 - (c) nemilinganiselo efanayo yokugcinwa kwenxili.
- (2) Uvimba wemali wezwelonke makaqinisekise ukuba ayathatyathwa amanyathelo asekwe ngokwesiqedwana (1), kwaye usenokukumisa ukufuduselwa kweemali kwicandelo likarhulumente ukuba elo candelo likarhulumente liyaphula loo milinganiselo ngokugqithisileyo okanye ngokuzingisileyo.

- (a) akuvumelekanga ukuba sikumise ukufuduswa kweemali ixesha elingaphezu kweentsulu ezili-120; kwaye
 - (b) sinokunyanzeliswa ngoko nangoko, kodwa siyakuphelelwa, kuqale emva ukuphelelwa oko, ngaphandle kokuba iPalamente iyavumelana nako emva kokwenzeka kwenkqubo ephantse ifane kanobom naleyo engokwesiqendu 76(1) nefunwa yimigaqo yendibaniselwano nayimiyalelo yePalamente.

 - (b) iphondo malinikwe ithuba lokuziphendula izityholo elibekwa zona, nelokucacisa elalo icala, phambi kwekomiti.

217. (1) Xa icandelo likarhulumente kurhulumente wezwelonke, kowephondo okanye kowasekuhlaleni, okanye naliphi na elinye iziko ekuthethwa ngalo kumthetho wepalamente wezwelonke, lingena kwisivumelwano sokufumana impahla okanye iinkonzo, malenze njalo ngokuvumelana nenkqubo engakhalazisiyo, eselubala, enokhuphiswano nengenazindleko.

 - (b) ukuba ugunyazwe ngumthetho wepalamente wezwelonke, unokufuna nezinye iirhafu neentlawulo ezifanelekileyo ukuba zifunyanwe ngurhulumente wasekuhlaleni okanye zifunyanwe ludidi lorhulumente wasekuhlaleni awela kulo loo masipala, kodwa akukho masipala uvumelekileyo ukuba afune irhafu, iVAT, irhafu yeentengiso okanye yokungena emideni yelizwe.
- (2) Igunya likamasipala lokufuna intlawulo ngemhlaba nemizi nangezinye iintlawulo ngeenkono ezenziwa okanye ezenziwa egameni lakhe—
- (a) alinakusetyenziswa ngendlela ephazamisa kanobom iinkqubo zoqoqosho zezwelonke, imisebenzi yoqoqosho eqhubeka kuwo onke amaphondo, okanye ukutyhutyha kwempahla, iinkonzo, imali okanye umsebenzi; kwaye
 - (b) kunokulawulwa ngumthetho wepalamente wezwelonke.
