**ANNOUNCEMENT OF DEDICATED COURTS FOR THE HEARING OF ALLEGED OFFENCES
ASSOCIATED WITH THE 2010 FIFA WORLD CUP**

1. The Department of Justice and Constitutional Development has a constitutional obligation to ensure that the rights of all the people who are within the borders of the country are protected. In the furtherance of this constitutional mandate the Department is putting extraordinary measures in place to ensure that the cases involving the multitude of soccer fans and participating teams who will be coming from all corners world for the World spectacle are fast tracked.

2. The Department, in conjunction with the Justice Crime Prevention and Security cluster which includes the South African Police Service, the National Prosecuting Authority (NPA), the Legal Aid South Africa (LASA) and the Judiciary, developed an Administration of Justice Plan to be implemented in order to deal with alleged offences associated with the 2010 FIFA World Cup. The courts listed in the Schedule below will, from 28 May 2010 to 25 July 2010, be open to the public to hear cases associated with the 2010 FIFA World Cup for the following times: 7h45-16h30 and 16h30 to 23h00.
