## DETERMINATION OF SALARIES OF PROSECUTORS UNDER SECTION 18(1) OF THE NATIONAL PROSECUTING AUTHORITY ACT, 1998

I, Jeffrey Thamsanqa Radebe, Minister for Justice and Constitutional Development, acting under section 18(1) of the National Prosecuting Authority Act, 1998 (Act No. 32 of 1998), and in consultation with the National Director of Public Prosecutions and after consultation with the Minister for Public Service and Administration and with the concurrence of the Minister of Finance, hereby determine, as indicated in Schedule 1, new salaries for prosecutors in terms of which the salary ranges specified in Column 2 shall, with effect from 1 July 2009, be applicable and payable to prosecutors.

This determination is deemed to have been published with effect from the 1st of July 2009 and therefore commences effective from the said date
