Umsebenzi we Khomishani wuku thuthukisa, ukugucula nokuphucula umthetho welizwe lase South Africa. I-Project 107 imayelana namacala aphantselane nezocansi. Enye yezingxenywe zale Project imayelana nokudayiswa kocansi ngabantu abadala.

IKhomishani ikhiphe iPhepha-ngoxoiswano elimayelana namacala aphantselane nezocansi: Ukudayiswa kocansi ngabantu abadala elingunombolo 1 lika 2009 umphakathi wacelwa ukuba uthumele imibono mayelana neziphakamiso ezicukethwe kuleliPhepha-ngoxoiswano ngungakafiki umhlaka 6 ku May onyakeni odlule. LeliPhepha-ngoxoiswano lihlose ukuzwa imibono yomphakathi ezosetshenziswa yiKhomishani ukuphuthula iReporti kanye noMthetho-sivivinyo.

Inhloso youkuqala yalolucwaningo ngukuphenya kabanzi ngemithetho eyahlukahlukene ephantselane nokudayiswa kocansi ngabantu abadala. Inhloso yesibili yalolucwaningo wukubheka ukuthi ngabe sikhona yini isidingo sokuguqula nokuphucula imithetho ephantselane nokudayiswa kocansi ngabantu abadala nokuveza imithetho-sivivinywa engahle isetshenziswe ekuhlahleni indlela, ukuvikela noma ukwehlisa ukudayiswa kocansi.

Okuzolandela emuva kwaleliPhepha-ngoxoiswano elimayelana namacala aphantselane nezocansi kuzoba yi Reporti. Kubhekwe ukuthi iReporti izophothulwa ngokuphela kwenyanga ka-February wonyaka ka 2011. iReporti izobe icukethe iziphakamiso zokugcina zeKhomishani ezizobe zihambisana

noMthetho-sivivinyo omayelana nokudayiswa kocansi ngabantu abadala. Kuzothi uma iRepoti isigunyazwe yi Khomishani inikezwe uNgcongcoshe woMnyango wezoBulungisa nokuThuthukiswa koMthetho-Sisekelo ukuze ayibuke.

3. **Chaza zonke iziphakamiso ezahlukene ezidalulwe emphakathini?**

Kubalulekile ukuthi zisuka-nje kucaciswe umthetho okunguwona olandelwayo njengamanje kulelizwe lase South Africa nokuthi futhi yimiphi imigomo ekufanele ilandelwe kulolucwaningo.

Okokuqala, ngaphansi koMthetho welizwe lakithi ukudayiswa kocansi ngenhloso, nokuthenga ucansi kumuntu omdala ngenhloso kanye futhi nezinye izenzo eziphathelene nokudayiswa kocansi kuphambene noMthetho.

Okwesibili, zonke iziphakamiso ezicukethwe kuleliPhepha-ngxoxiswano zikubona kuyicala ukudayiswa kocansi ngabantu abasebancane; ukuphoqelela ukudayisa ucansi ngaphandle kwesivumelwano; kanye futhi nokuhweba ngabantu ngenhloso yokudayisa ucansi. IKhomishani ibona ukuthi ukuphoqelela umuntu ukudayisa ngocansi kuphambene nomthetho kanti futhi lesisiphakamiso kufanele sifakwe kwi-Repoti yeziphakamiso zokugcina zeKhomishani.

iKhomishani iphakamisa leziphakamiso ezine ezilandelayo zomthetho ohlongozwayo ezingahle zisetshenziswe kulelizwe lase-South Africa:

Isiphakamiso sokuqala sithi akube yicala eliphelele izenzo zabantu eziphathelene nokudayiswa kocansi, lokhu kuhlenganisa umuntu odayisa ucansi, umuntu odayiselwa ucansi nabantu izenzo zabo ziphathelene nokudayiswa kocansi (ngamanye amagama lokhu nguwona mthetho olandelwayo njemamanje kulelizwe lase-South Africa)

Isiphakamiso sesibili sithi akube yicala elingaphelele izenzo zabantu ezihambisa ukudayiswa kocansi, amabhizinisi okudayisa ucansi kanye namakhasimende ocansi. Abantu okuyibona abadayisa ucansi abaphuli umthetho ngoba babonwa kungabantu okufanele bavikelwe.

Isiphakamiso sesithathu sithi akulawulwe futhi kuvunyelwe ngokomthetho ukudayiswa kocansi kuhambe ngendlela ebekiwe njengokukhipha amalicense wamabhizinisi ocansi, kubhaliswe abantu abadayisa ngocansi kanti futhi izindawo eziyingozi lapho abantu abadayisa ngocansi besebenzela khona zidalulwe. Ngaphansi kwalesisiphakamiso, ukudayiswa kocansi ngabantu abadala kuvunyelwe, kodwa kufanele kuhambe ngendlela ebekiwe. Ukudayiswa kocansi okungahambi ngendlela ebekiwe akube yicala.

Isiphakamiso sesine sithi ukudayisa ucansi akungabonwa njengesenzo esiphambene nomthetho. Lokhu kuhambisana nokuthi ukudayiswa kocansi kuthathwa njengenye yezidlela ezivunyelwe zokusebenza- kodwa ukusetshenziswa kwemithetho yabasebenzi kuloludaba akusho ukuthi lokho kuyikona sizathu sokungaphuli umthetho. Kudwa akuthathwe njengomgomo obekwe nguhulumeni.

Amandla weKhomishani mayelana ne Project 107 awancikanga emdlalweni webhola yendebe yomhlaba ka-2010, yingakho iKhomishane ingeke futhi ingasoze ibeke iziphakamiso ngalesisikhathi kololudaba.

yalolucwaningo wokuphucula kabanzi indlela yokuhanjiswa kobulingiswa ngokuphathelene nawo onke amacala amayelana nocansi kanye nokudayiswa kocansi ngabantu abadala, nokucwaningisisa imithetho ephethelene namacala ukuze kwenziwe iziphakamiso-sivivinyo ezihlose ukuphucula izindlela zokuhanjiswa kobulungiswa ukuze kulwiswe udlame oluhambisana nocansi nokuthi lezi iziphakamiso-sivivinyo zilethe izinguquko.
